STUDENT'S RIGHT TO CANCEL

"Student's Right to Cancel:

If the student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.

- The student has the right to cancel and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later.
- After the end of the cancellation period, you also have the right to stop at any time, and you have the right to receive a pro-rata refund if you have completed sixty (60) percent or less of scheduled clock hours in the payment period.
- Cancellation occurs when the student gives written notice of cancellation to Two Twenty Academy
- The cancellation date will be determined by the postmark date, if mailed, or the delivery date if delivered or electronically sent.
- This written notice need not take any form; it needs only to state you wish to cancel your enrollment agreement.

If a student is rejected for training or if a course is cancelled, the student will receive a refund of all monies paid.

- A student has the right to cancel the Enrollment Agreement and obtain a full refund of all charges, except the non-refundable registration fee of \$250 or less, through attendance at the first class session, or the seventh (7th) calendar day after enrollment, whichever is later.
- All other fees, including tuition and charges for books, tools, and supplies, will be refunded in full provided the student has not received or signed for the materials.
